WHY REMOTE LEARNING

In the event that school cannot be conducted in person on a given day or days due to health and safety issues, a lack of staffing, a facilities issue, a safety issue, or other emergency situation, ASU Preparatory Academy will have remote learning days in order to maintain continuity of learning.

Individual students may be placed on an a short term remote learning plan should the need arise due to health emergency, family emergency, or other extenuating circumstance.

School Support

Teachers are available for support an all learning materials are posted online



Students Learn at Home

Students learn from home. Supported by the school staff.



Remote Attendance

Families will log attendance through our SIS based on student work completed at home

The teacher guides students in working on their personalized path and sets the goals and outcomes for remote learning days.
